### Medication Safety Tips

1. Keep medication out of the reach of children.
2. Take medication as prescribed. Follow the instructions of your healthcare provider.
3. Do not share your medication with others.
4. Keep medication in its original container.
5. Store your medication in a cool, dry place.
6. Dispose of unused, unwanted, expired medication properly.



### Rules of the Box

#### ACCEPTABLE

- Prescription drugs
- Over-the-counter medications
- Ointments and creams
- Pet medications
- Sprays
- Liquids
- Inhalers

Cross out personal information or peel off the label.

Place all medication in a sealed bag and place into the drop box.

#### NOT ACCEPTABLE

- Biohazardous materials
- Needles/sharps/syringes
- Illegal Drugs



Take it to THE BOX

### Why use the drop boxes?

- Prevent poisonings and overdoses.
- Help protect Lake Michigan.
- Reduce the risk of illegal use.

The Medication Disposal program has collected 10 tons of unused, unwanted, and expired medication since 2009.

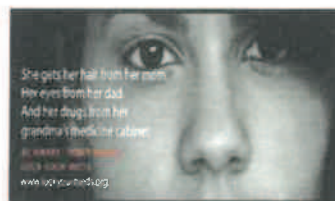

# VILLAGE ORDINANCE

## Lawn, Grass, Weed Control

### Sec. 8-1-4 (B)

**Public Nuisance Declared.** The Village Board finds that lawns, grasses and noxious weeds on non-agricultural lots or parcels of land, or in designated open space areas in a conservation subdivision (as classified under the Zoning Code governing the Village), within the Village of Bristol which exceed eight (8) inches in length adversely affect the public health and safety of the public in that they tend to emit pollen and other discomfiting bits of plants, constitute a fire hazard and a safety hazard in that debris can be hidden in the grass, interferes with the public convenience and adversely affects property values of other land within the Village. For that reason, any non-agricultural or conservancy subdivision designated open spaces, lawn, grass or weed on a lot or other parcel of land which exceeds eight (8) inches in length is hereby declared to be a public nuisance. Notwithstanding, these provisions do not apply to grass grown for production agricultural purposes; land in a designated floodplain, wetland, or water detention area; land in designated open space areas in a conservation subdivision; or land used for non-residential purposes. When a residence, farmstead or business is located on a large parcel, compliance with this Section and Section 8-1-5 is required for the one (1) acre around such buildings.

### TIPS ON WHEN AND IF TO BURN:

Please remember to get a burn permit if you have not done so already for 2018. Always call the "Burn" line just before burning at 262-857-4063 to find out if burning is permitted.

Please remember to follow the guidelines that are on the permit as conditions can change during the day.

You need a burn permit when burning anything outside with the exception of a grill. If you have any questions about burning, please do not hesitate to call the Fire Department at 262-857-2711.

# Coyote

Coyotes are naturally secretive creatures, but they are opportunistic hunters. If food is available in your neighborhood you may see them, day or night. Coyotes primarily feed on small rodents and rabbits, and are an important member of the food chain because of this tendency, but coyotes will eat anything they can find, including fruit, vegetables and insects. Their presence can be unnerving or frightening for people unused to coyotes, but generally they are more afraid of you than you are of them. In some cases, they may attack and kill small pets, although coyote attacks on humans are exceptionally rare. There are numerous ways to manage the presence of coyotes in your area.

## Do Not Feed Wildlife

- Do not store pet food out of doors, and keep pet food bowls inside when not in use.
- Do not keep trash out of doors, or keep it secure with tight-fitting lids.
- Do not provide food and water for other wildlife. Rodents are attracted to bird seed, and they are a coyote's natural prey. Coyotes will also eat bird seed, fruit, and compost for an easy meal.

## Protect Your Pets

- Keep cats indoors and watch dogs when outdoors. Only leave pets unattended when they are secure in a kennel with a covered top.

## Discourage Coyotes

- Clear brush and undergrowth in your yard that can provide cover for coyotes or habitat for important coyote prey species.
- Scare tactics can be used if you see a coyote in your yard or while out walking. Yell and make loud noises, shake or throw pop cans filled with coins, throw a ball, shoe, sticks or other object in the direction of the coyote and/or spray the coyote with water. You can also buy ultrasonic dog repellents or pocket-sized air horns.
- Fencing 6–7 feet high and buried approximately 1 foot deep can help keep all but the most determined coyotes out of an area.
- Pick up all fallen fruit from fruit trees, keep compost secure, and make sure trash cans are tightly lidded and secure. Never leave loose trash outside.



## Quick Facts

- Coyotes are omnivores that will eat anything edible. In the above photo, for example, a coyote caught a squirrel at a bird feeder.
- Urban coyotes tend to use what natural green space is available, including parks and cemeteries.
- Urban coyotes are usually more nocturnal (active at night) than their rural relatives, but may be active during the day if they are feeding pups or weren't successful in hunting the night before.
- Trapping and hunting of coyotes is legal year-round on your property without a DNR license. Many municipalities have regulations about the discharge of firearms. Please check with your local government to ensure adherence to local ordinances.
- Lethal removal is recommended for coyotes that display aggressive behavior towards humans.

The following section has been reprinted from the 2011 Wisconsin Trapping Regulations.

**Landowner Provisions:** The owner or occupant of any land and any family members who live with them do not need a license to:

Trap coyote, beaver, fox, raccoon, woodchuck, rabbit, and squirrel on the land year-round (see "Beaver Damage Control" on page 17 for more information).

Live trap with cage or box traps for beaver, coyote, fox, woodchuck, rabbit, raccoon, and squirrel on the land at any time in cities, villages, or other areas where the discharge of firearms is unlawful. Live-trapped animals must be either humanely killed or released within 24 hours on unenclosed private land with the landowner's permission.

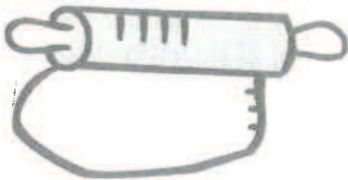
**Beaver Damage Control:**

Landowners, occupants, and family members living with them may hunt or trap beaver on their land at any time without a license. If beaver are taken by firearm, the landowner, occupant, or family member harvesting the beaver must be at least 10 years old and comply with firearm possession and hunting mentorship program restrictions (see 2011 Small Game Regulation). Landowners may also trap on beaver dams. Beaver dams may be removed without a permit by the landowners, lessees, or occupants of the land.

1. Pies must be homemade with crusts and filling made from scratch. No store bought crust, dough or canned fillings may be used. Each pie must contain a least a bottom crust.
  2. The pie must be entered by the person who made it.
  3. It is strongly recommended that pies are baked in disposable pans, as pans will not be returned.
  4. Refrigeration is not available, therefore, no pies that require refrigeration will be accepted.
  5. Baker must bring two (2) identical pies. Pies must be checked in by 1:30 pm on contest day. If recipe contains nuts, please notify staff when dropping off pies for appropriate labeling.
  6. Following judging, the pies will be sold to attendees, by the slice or whole pies. All proceeds will go to Bristol Progress Days Inc. The top 3 placing pies will be sold at the auction on Sunday
  7. A copy of the recipe would be appreciated with submittal of the registration but not required. Recipes may be made public after contest.
- \* If you wish to bake a pie and not have it judged, we will be happy to accept it and sell it to raise funds for Bristol Progress Days Inc.  
\*\* NO LIMIT ON THE NUMBER OF PIES YOU MAY ENTER.
