Village Budget Update

The 2023 Village Budget was presented and approved during the Budget Hearing on Monday, October 10th. The Village Board voted to postpone the property reassessment until 2024 and keep the MIL rate at 2.6449 per \$1000 of assessed value in an effort to keep taxes lower for residents.

Real and Personal Property Tax Bills

The 2022 Real and Personal Property tax bills will include the annual garbage fees. The Village is working closely with Kenosha County to calculate and print the tax bills. Per WI state statute, tax bills will be mailed to residents by the 3rd week in December. The first installment will be due by January 31st, 2023 and can be paid at or mailed to the Village of Bristol. Any payments made after January 31st, including the second installment, is paid at the Kenosha County building on the corner of Hwys 45 & 50.

Water Rate Increase – as of October 1st, 2022

The notice below was mailed to residents in June 2022 and included in the 2nd and 3rd quarter village newsletters. The new water rates reflected on the 4th quarter billing will be:

Notice of Rate Increase Water Customers of the Bristol Water Utility

This is to give you notice that the Bristol Water Utility will file an application on June 21, 2022, with the Public Service Commission of Wisconsin (PSC), for authority to increase water rates. Rates for general service will increase 4.5 percent. The increase is necessary to reduce the existing deficiency in present rates. The request is being made under Wis. Stat. 196.193. Rate increases granted under this statute do not require a public hearing. The effect of the increase for some selected customers is shown below. Public Fire Protection and Wholesale rates (if applicable) will also increase 4.5 percent.

Village of Bristol Fire Department

Notes from the Fire Dept





Often called the invisible killer, carbon monoxide is an invisible, odorless, colorless gas created when fuels (such as gasoline, wood, coal, natural gas, propane, oil, and methane) burn incompletely. In the home, heating and cooking equipment that burn fuel can be sources of carbon monoxide.

- CO alarms should be installed in a central location outside each sleeping area and on every level of the home and in other locations where required by applicable laws, codes or standards. For the best protection, interconnect all CO alarms throughout the home. When one sounds, they all sound.
- Follow the manufacturer's instructions for placement and mounting height.
- Choose a CO alarm that is listed by a qualified testing laboratory.
- Call your local fire department's non-emergency number to find out what number to call if the CO alarm sounds.
- Test CO alarms at least once a month; replace them according to the manufacturer's instructions.
- If the audible trouble signal sounds, check for low batteries.
 If the battery is low, replace it. If it still sounds, call the fire department.
- If the CO alarm sounds, immediately move to a fresh air location outdoors or by an open window or door. Make sure everyone inside the home is accounted for. Call for help from a fresh air location and stay there until emergency personnel declare that it is safe to re-enter the home.
- If you need to warm a vehicle, remove it from the garage immediately after starting it. Do not run a vehicle or other fueled engine or motor indoors, even if garage doors are open. Make sure the exhaust pipe of a running vehicle is not covered with snow.
- During and after a snowstorm, make sure vents for the dryer, furnace, stove, and fireplace are clear of snow build-up.
- A generator should be used in a well-ventilated location outdoors away from windows, doors and vent openings.
- Gas or charcoal grills can produce CO only use outside.





Have fuel-burning heating equipment and chimneys inspected by a professional every year before cold weather sets in. When using a fireplace, open the flue for adequate ventilation. Never use your oven to heat your home.

FACTS

- A person can be poisoned by a small amount of CO over a longer period of time or by a large amount of CO over a shorter amount of time.
- (1) In 2010, U.S. fire departments responded to an estimated 80,100 nonfire CO incidents in which carbon monoxide was found, or an average of nine calls per hour.

Utilities – Public Works Update

When shoveling your driveway, as you're facing the road, place the snow to the right of your driveway to minimize the spill over from the snowplow coming back in your driveway.

When plowing, plan accordingly, as it is against Village and County ordinances to plow onto and across the road.

<u>Do not park on Village streets:</u> Parking on village streets prevents snowplow drivers from plowing during the winter months where cars are parked. It also makes it difficult for emergency vehicles to get through in the event of a fire or emergency call. Parking on the streets is against the village ordinance and may result in a fine.

Please check your mailboxes to see that they meet proper installation requirements. (See the previous newsletter for more information and diagrams.)

USEFUL INFORMATION

Please visit our website villageofbristol.org to make the following types of payments (except Burn Permits):

*Payments can be made at the village office during office hours or can be placed in the drop box located by the front entrance doors. If you would like a receipt, please include a self-addressed stamped envelope.

BURN PERMITS (payments not available online)

Outdoor fires require a burn permit which is valid January-December. Please call the Fire Department Burn Line at 857-4063 for the current burn status just prior to burning. Permits can be purchased at the Village Hall during regular business hours or at the Fire Department nights and weekends. First time permits are \$25, and renewals are \$15.

BUILDING PERMITS

If you are doing any type of home renovations, please visit our website and complete a <u>building permit</u> application. A <u>zoning permit</u> is also required in addition to the building permit if you are building a garage, shed, fence, accessory building, or adding on to a building.

CREDIT CARD PAYMENTS at the Village Office

The Village of Bristol is now accepting credit card payments in the village office for anything payable to the village. There is a convenience fee of 3%.

ONLINE PAYMENTS NOW AVAILABLE!

Payments can now be made online for: sewer/water bills, taxes, invoices payable to the village, traffic citations, and building permits. There is a 2.75% convenience fee if paying with a debit or credit card, or a \$1 fee if paying by e-check. Visit our website to make your payments.

RECYCLING CENTER

Accepts: brush, grass, leaves, cooking oil, waste oil, anti-freeze, scrap steel.

Additional Hours: April-Nov: 1st & 3rd Wed. 3pm-6pm, and 1st & 3rd Sat. 9am-noon.

Dec-March: 1st Sat 9am-noon
