

ORDINANCE NO. 2014-18

AN ORDINANCE REGARDING CONDITIONAL USE PERMITS FOR CERTAIN MOBILE TELECOMMUNICATIONS FACILITIES USES

The Village Board of the Village of Bristol, Kenosha County, Wisconsin, do ordain as follows:

SECTION I. AMENDMENT OF PROVISIONS.

The use listings of the following designated residential zoning districts of the Village of Bristol Code of Ordinances [Title 13, Chapter 1, Article C] are amended by the addition of the following: A-1 Agricultural Preservation District; A-2 General Agricultural District; A-3 Agricultural Related Manufacturing, Warehousing and Marketing District; A-4 Agricultural Land Holding District; R-1 Rural Residential District; R-2 Suburban Single-Family Residential District; R-3 Urban Single-Family Residential District; R-4 Urban Single-Family Residential District; R-5 Urban Single-Family Residential District; R-6 Urban Single-Family Residential District; R-6A Urban Single-Family Residential District (Lake); R-7 Suburban Two-Family and Three-Family Residential District; R-8 Urban Two-Family Residential District; R-9 Multiple-Family Residential District; R-10 Multiple-Family Residential District; R-11 Multiple-Family Residential District; R-12 Mobile Home/Manufactured Home Park; B-1 Neighborhood Business District; B-2 Community Business District; B-3 Highway Business District; B-4 Planned Business District; B-5 Wholesale Trade and Warehousing District; M-1 Limited Manufacturing District; M-2 Heavy Manufacturing District; M-3 Mineral Extraction District; M-4 Sanitary Landfill and Hazardous Waste Disposal District; I-1 Institutional District; PR-1 Park-Recreational District; C-1 Lowland Resource Conservancy District; and C-2 Upland Resource Conservancy District:

Permitted Uses:

- () Class 2 collocation of a new mobile service facility on an existing support structure without substantial modification, per Section 13-1-362.

Conditional Uses:

- () Siting and construction of any new mobile support structure and/or facility or a Class 1 collocation of a new mobile service facility on an existing support structure, per Section 13-1-362.

SECTION II. SEVERABILITY.



SECTION III. EFFECTIVE DATE.


This Ordinance shall take effect upon passage and publication as provided by law.
