

**ORDINANCE NO. 2016-12**

**AN ORDINANCE AMENDING THE AGRICULTURAL DISTRICTS & R-1 DISTRICT  
TO PROVIDE FOR A SPECIAL EVENT/WEDDING BARN CONDITIONAL USE**

The Village Board of the Village of Bristol, Kenosha County, Wisconsin, do ordain as follows:

**SECTION I. AMENDMENT OF PROVISIONS.**

Section 13-1-84(d) of the Village of Bristol Code of Ordinances is amended with the addition of the following Subsection (15):

- (15) Special event/wedding barns meeting the requirements of Section 13-1-177(b)(133).

**SECTION IV. AMENDMENT OF PROVISIONS.**

Section 13-1-85(d) of the Village of Bristol Code of Ordinances is amended with the addition of the following Subsection (15):

- (15) Special event/wedding barns meeting the requirements of Section 13-1-177(b)(133).

**SECTION V. AMENDMENT OF PROVISIONS.**

Section 13-1-86(d) of the Village of Bristol Code of Ordinances is amended with the addition of the following Subsection (7):

- (7) Special event/wedding barns meeting the requirements of Section 13-1-177(b)(133).

**SECTION VI. SEVERABILITY.**

If any provision of this Ordinance is invalid or unconstitutional or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provisions or applications.

**SECTION VII. EFFECTIVE DATE.**


This Ordinance shall take effect upon passage and publication as provided by law.
