You are invited to attend a public information meeting to stay connected with the reconstruction project of the US 45 and County K intersection (Bristol Road & 60th Street). A project location map is attached.

Within the last year, two public information meetings were held to present the reconstruction project and potential options for the US 45 and County K intersection. After those meetings the comments that were received were reviewed and taken into consideration when the decision of moving forward with the roundabout intersection control to construct was determined.

Since that time the property at 6030 Bristol Road, USH 45 was determined to be eligible for inclusion on the National Register of Historic Places and therefore identified for 4(f) protection. The purpose of this meeting is to inform and present the impacts of the improvements on this property, offer an opportunity for questions and answers with the project team, and to obtain public input related to this impact. The meeting will be an informal open house where representatives from the WisDOT project team will be available to discuss the proposed project and address any questions or concerns. A formal presentation will not be given.

The US 45 and County K intersection has experienced more than double the allowable threshold of crashes per year. The majority of the collisions at this intersection have resulted in either injuries or fatalities, making this intersection listed in the top 5% of hazardous intersections in the region, and qualifying for the federal Highway Safety Improvement Program (HSIP) funding. To meet the goal of the project, which is to provide the greatest improvement to the safety of the intersection, a single lane roundabout will be constructed. The roundabout will significantly reduce the right angle crashes, the impact angle and the high speed impact crashes. Exhibits of the project will be on display and informational handouts will be provided.

If you have any questions or concerns that may assist in the development of this project, we encourage you to attend the meeting. 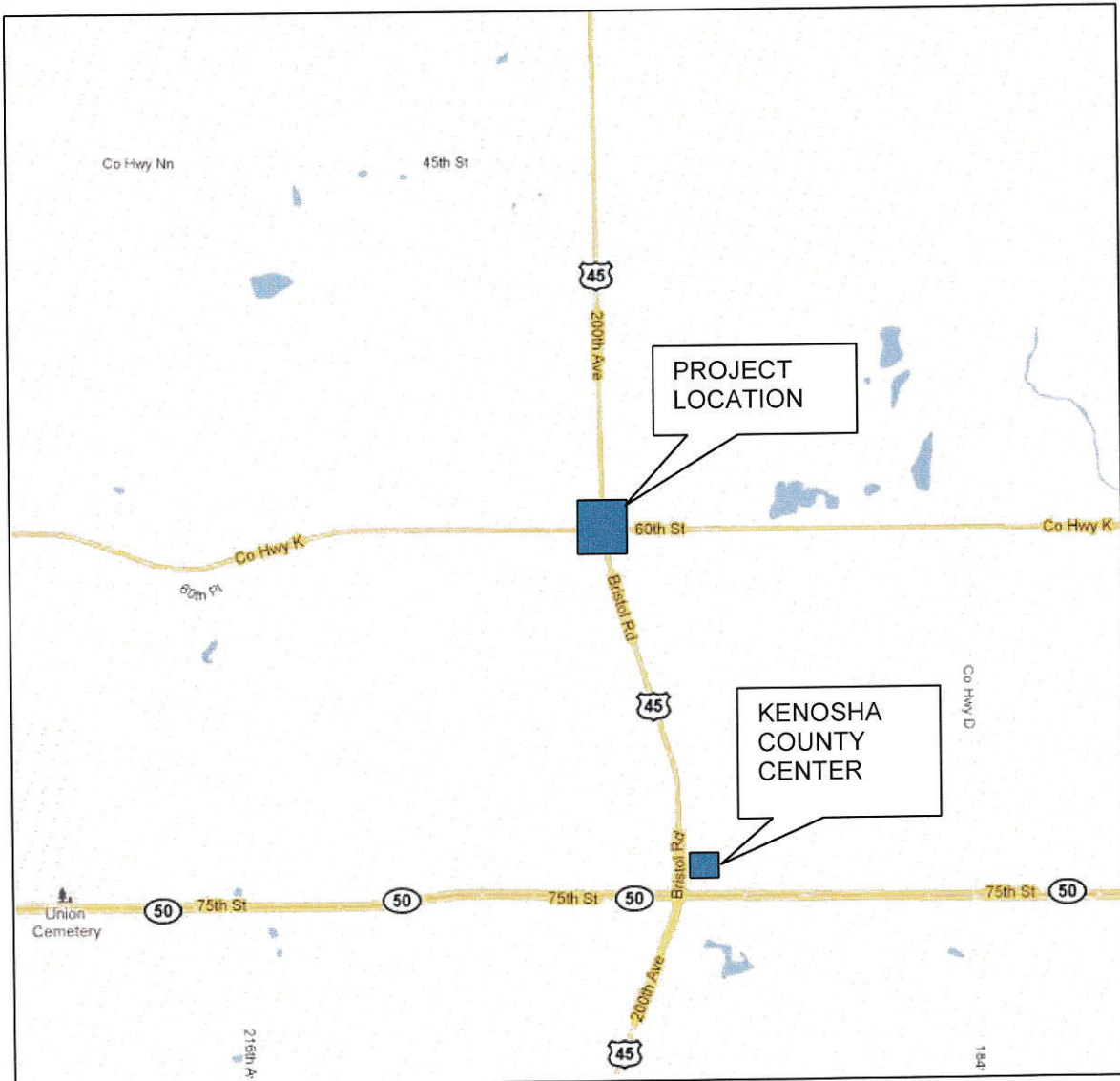
Enc.: Location Map
