Dear Homeowner,

Beginning Thursday, October 6th and continuing for approximately 4 weeks, Rainbow Lake Manor will perform a road reconstruction project on Candlelight Lane from the community entrance to Rainbow Drive. This project will involve the removal and rebuilding of the existing roadway and curbs.

During construction, Candlelight Lane will remain open and passable. However, between the hours of 7:00 am through approximately 4:30 pm, construction crews will be onsite with heavy equipment. Should you need to drive along Candlelight Lane during these hours, please proceed with caution, be alert for construction crews and pay attention to direction from construction personnel. At no time will the road be impassable to emergency vehicles.

If you live along Candlelight Lane, please read the following instructions:

1. All curbs and about 3 feet of your driveway apron are to be removed and replaced.
2. Once the concrete is poured for the replacement curbs and driveways, you will not have vehicle access to your driveway for approximately 5-7 days as we allow the concrete to settle and cure.
3. During this time, overnight (5:00 pm – 7:00 am) on-street parking will be allowed on the east side of Candlelight Lane.
4. Additionally, if you are unable to find a place to park on the street, you may park in the office parking lot.
5. If you have any special needs or appointments during the construction period, please contact the office to make special arrangements.

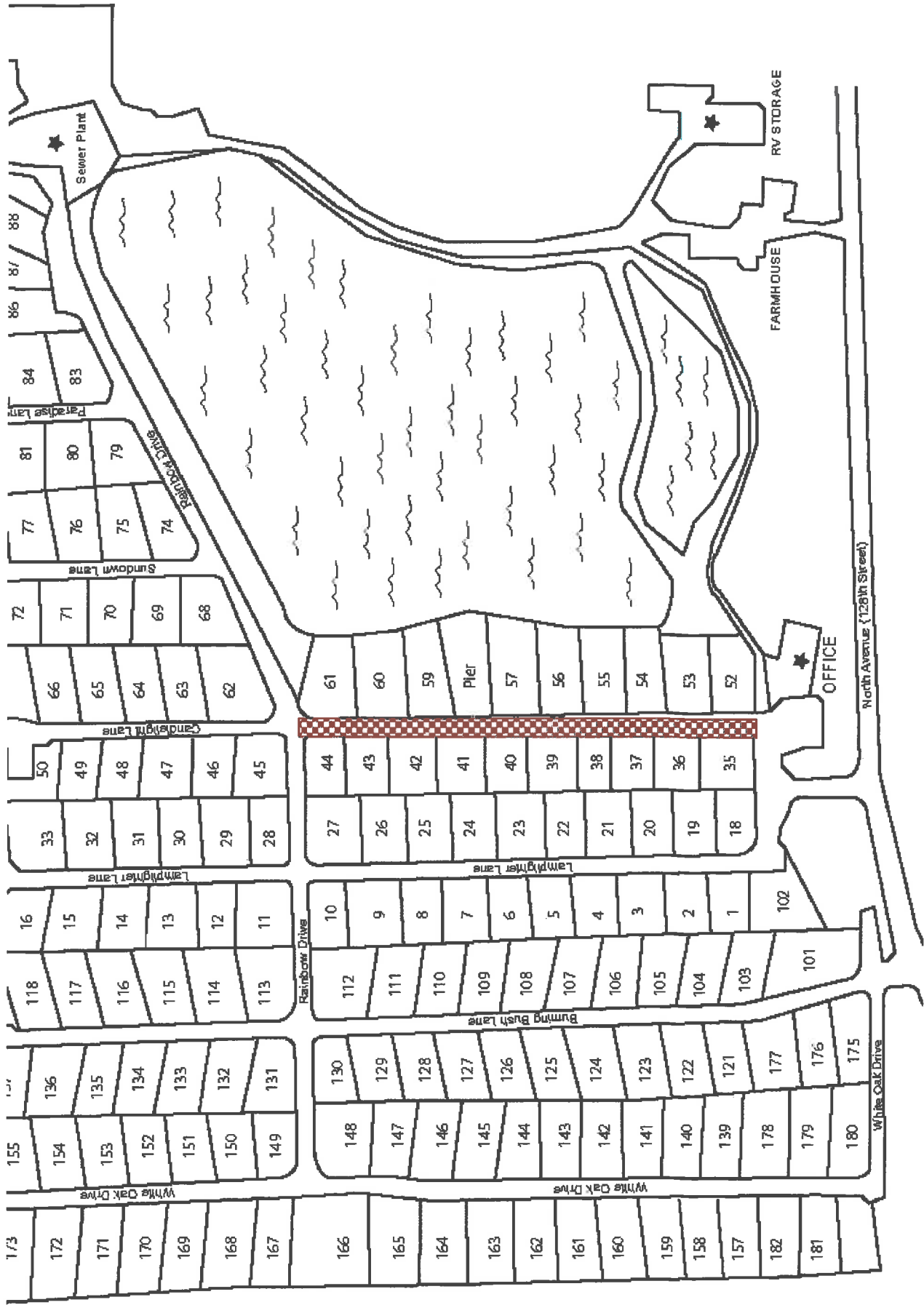


