KENOSHA COUNTY INTERACTIVE MAPPING

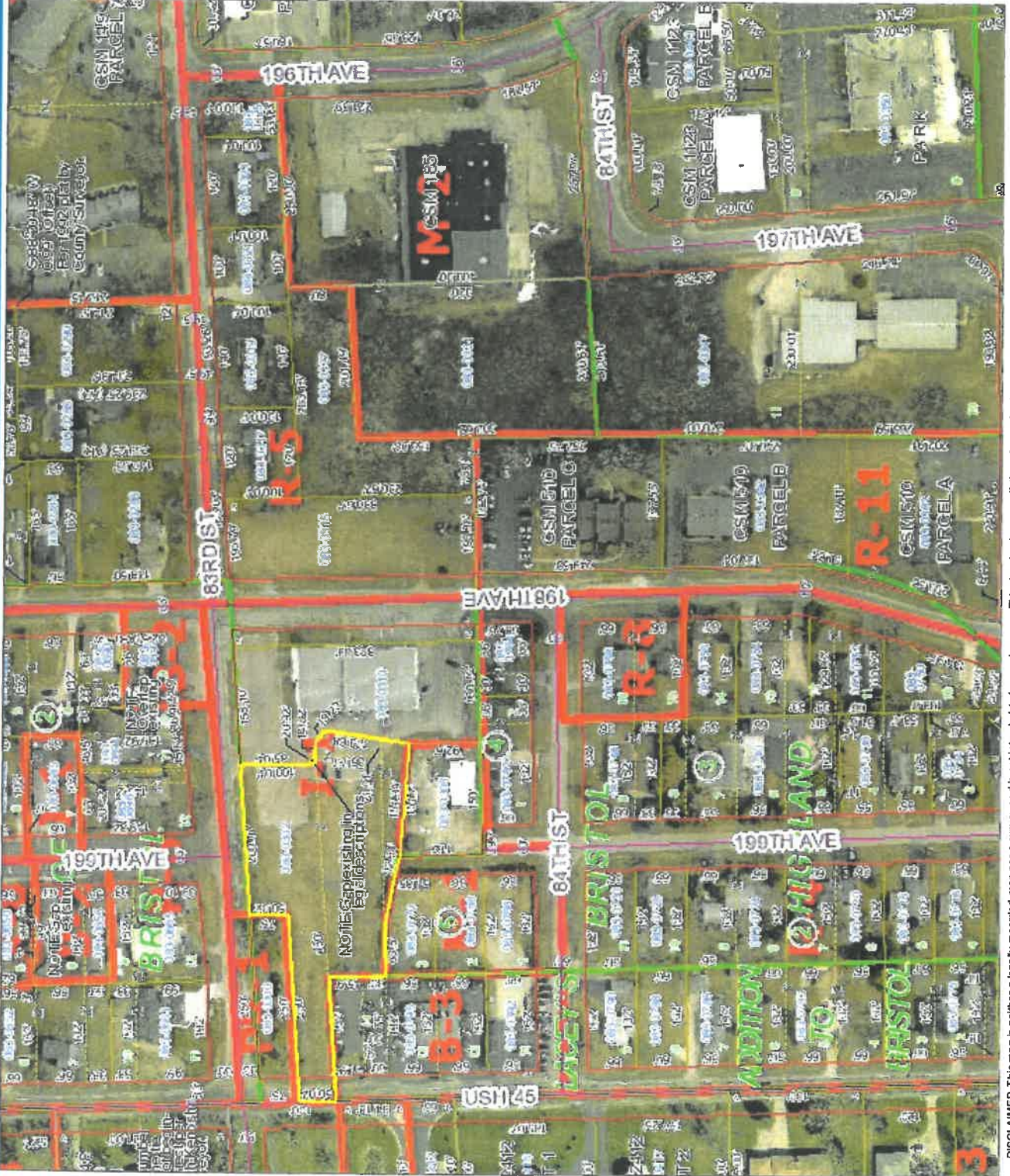
