

**ORDINANCE NO. 1-2018**

**AN ORDINANCE WAIVER OF FEES BY ADMINISTRATOR**

The Village Board of the Village of Bristol, Kenosha County, Wisconsin, do ordain as follows:

**SECTION I. ADOPTION OF PROVISIONS.**

Section 7-14-3 of the Village of Bristol Code is created to read as follows:

**Sec. 7-14-3 Waiver of Fees by Village Administrator.**

When deemed to be in the public interest, the Village Administrator is authorized to waive license and permit fees established in this Code of Ordinances or other Village fee schedules for civic, community or charitable organizations. Such waiver authority shall not include the following license and permits:

- (1) Dog and other animal licenses under Title 7, Chapter 1.
- (2) Retail "Class A" Intoxicating Liquor Licenses under Title 7, Chapter 2.
- (3) Retail "Class B" Intoxicating Liquor Licenses under Title 7, Chapter 2.
- (4) Reserve "Class B" Licenses under Title 7, Chapter 2.
- (5) Class "A" Fermented Malt Beverage Licenses under Title 7, Chapter 2.
- (6) Class "B" Fermented Malt Beverage Licenses under Title 7, Chapter 2.
- (7) Wholesale Fermented Malt Beverage Licenses under Title 7, Chapter 2.
- (8) Retail "Class C" Wine Licenses under Title 7, Chapter 2.
- (9) Cigarette Licenses under Title 7, Chapter 3.
- (10) Tattooing and Body Piercing Licenses under Title 7, Chapter 9.
- (11) Junk and Automobile Salvage Yard Licenses under Title 7, Chapter 10.
- (12) Amusement Park Licenses under Title 7, Chapter 11.
- (13) Large Livestock Operation permits under Title 7, Chapter 12.

**SECTION II. SEVERABILITY.**


If any provision of this Ordinance is invalid or unconstitutional or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provisions or applications.


**SECTION III. EFFECTIVE DATE.**


