

ORDINANCE NO. 2019-16

AN ORDINANCE REGARDING PERMIT FEES FOR LARGE BUILDINGS

The Village Board of the Village of Bristol, Kenosha County, Wisconsin, do ordain as follows:

SECTION I. AMENDMENT OF PROVISIONS.

Section 1-3-1 "Fee Schedule" of the Village of Bristol Code of Ordinances is amended with the following addition pertaining to building permit fees for large commercial buildings:

Building Permit Fees – Large Commercial Buildings

The Village of Bristol has been authorized by the Wisconsin Department of Safety and Professional Services to perform plan reviews for building, HVAC, plumbing and fire protection system plans for projects of any size.

Fees for this plan review service and related building permits are as follows:

Building and HVAC Systems (square footage & permit fees in dollars)

Area (Square Feet)	Building Plans	HVAC Plans
100,001 - 200,000	25,000	6,000
200,001 - 300,000	28,000	8,000
300,001 - 400,000	31,000	10,000
400,001 - 500,000	34,000	12,000
Over 500,000	37,000	14,000

Fire Protection Systems (square footage & permit fees; fee includes plan review and inspection)

Area (Square Feet)	Fire Alarm	Fire Suppression
100,001 - 200,000	2,000	2,000
200,001 - 300,000	2,500	2,500
300,001 - 400,000	3,000	3,000
400,001 - 500,000	3,500	3,500
Over 500,000	4,000	4,000

Plumbing plan review fees are calculated on the application form

SECTION II. SEVERABILITY.

If any provision of this Ordinance is invalid or unconstitutional or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provisions or applications.

SECTION III. EFFECTIVE DATE.


This Ordinance shall take effect upon passage and publication as provided by law.
